## INTRODUCTION

This supplement provides information for playing an expanded “Turning Table”, under the Basic Fantasy Role-Playing Game rule system. If you do not already have a copy of the Basic Fantasy RPG rules, please visit the website and download a copy.

### Expanded Turning Table

The following table has been design using the Cleric vs. Undead table found on page 50 of the BFRPG rulebook.

It allows for the creation of new and stronger undead as the creation of new classes and sub-classes that relies on a “turning” mechanic.

To use the table the player compares the character's level against he the HD or Level of the objective with the following observations:

1-Against creatures with variable HD amounts the GM must use the lesser of these values.

2-Those creatures having either a special ability [marked as an asterisk (\*) on their HD] or that requires a special weapon to be hit [marked as a dagger/double dagger (†/‡) on their AC] are treated as having DOUBLE of their HD value.

3-Some creatures (specially those of non-aggressive/threatening nature) are treated as having HALF their HD.

“A” means that the use of the Turning or similar ability Automatically succeed.

“S” means that a Special result is achieved (such as the Damage for Cleric's vs. Undead).
